1 Introduction

1.1 Details

You may also include subsections if they help organize your text, but they are not required. Use as many sections and subsections with whatever names work for your submission!

Another tip. In some cases, it may be helpful to use `paragraph` to title individual paragraphs. For example, if a section describes features for a classifier, you can optionally title each paragraph with the name of each feature.

2 Elements

2.1 Citing elements

Here are some examples of how to construct and reference common elements in LaTeX. References to elements such as tables, figures, equations and sections make use of `label` names that you set. References to citations should use the labels you indicate in `bibliography.bib`. Change all of these examples and values with your own data.

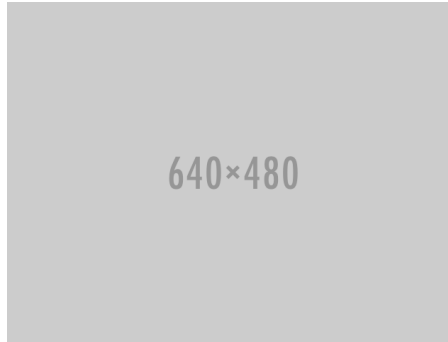


Figure 1: Example figure and figure caption.

We can cite Table 1 as well as Figure 1, and we also cite an example paper [4]. We can also include mathematical notations, such as:

$$f(y) = x^2. \tag{1}$$

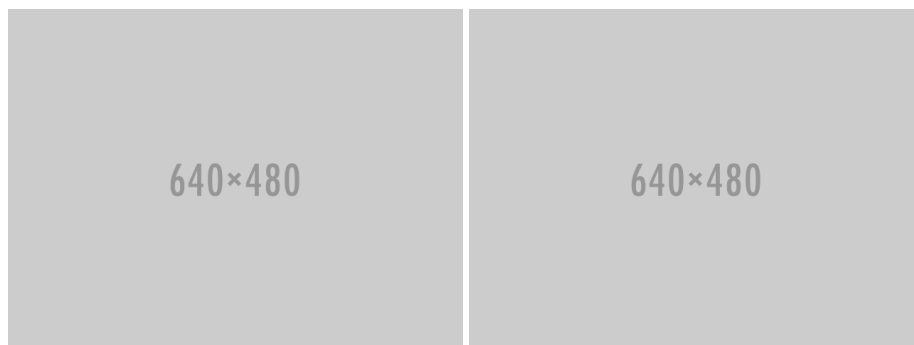


Figure 2: Example figure, where two .png are placed side by side.

The line number of the equation can be cited as Equation 1. You can also cite multiple papers together [1, 2, 3], and reference figures or tables indirectly in parentheses (Figure 2). You can also cite other sections or subsections of your paper, such as §1.1.

2.2 Required specifications

Tables and figures should *not* appear at the top of the first page above the paper title and abstract, but can be placed within the main text, as exemplified by Table 1. They may also be placed at the top of non-first pages, as exemplified by Figures 1 and 2. Figures and tables discussed in the main text should appear *before* the References section. Supplementary materials should be referenced by their relevant Appendix section, such as Appendix A.

Do *not* change the font size of table and figure captions, or the spacing between text lines, section/subsection titles, tables, figures, and captions. You should size your figures and tables so that they stay within the `linewidth` of the paper.

Acknowledgements

This unnumbered section should be blank when submitting your paper. After review, you may include lists of people and organizations who supported the work.
