# Between Woolf and Homer: An Explorative Approach to Intertextuality Detection using Large Language Models

#### **Abstract**

This paper investigates the potential of Large Language Models (LLMs) for computational analysis of intertextual relationships in literary texts, focusing specifically on the methodological challenges of operationalizing complex literary concepts. We propose a two-stage approach that combines semantic similarity search with prompt-based analysis to examine intertextual connections between Virginia Woolf's *Mrs. Dalloway* and Homer's *Odyssey*. Through systematic evaluation of both expert-informed and naive prompting strategies, we demonstrate that while LLMs show promise in detecting sophisticated literary relationships, their performance depends critically on the effective operationalization of domain knowledge. Our results indicate that expert-informed prompts achieve higher theoretical alignment (+16.23%) but also reveal a tendency toward over-interpretation, with 90% of analyses claiming classical transformations.

Keywords: intertextual relations, large language models, retrieval augmented generation

## 1 Introduction

The emergence of large language models (LLMs) has created new opportunities for computational approaches to literary analysis, while simultaneously raising fundamental questions about the operationalization of complex literary concepts. Traditional computational methods (be it rule-based, statistical or classical machine learning) have often struggled to capture the nuanced nature of intertextual relationships, particularly those operating at implicit or structural levels. However, recent advances in LLM capabilities – specifically in-context learning and chain-of-thought reasoning – suggest potential new approaches to this methodological challenge.

Intertextuality, as conceptualized by Kristeva and later systematized by Genette, presents a particularly compelling case for investigating the possibilities and limitations of LLM-based literary analysis, as the challenge lies not merely in detecting surface-level textual similarities but in engaging with the multiple levels of textual interaction that characterize literary influence. While previous computational approaches have often defaulted to simplified similarity metrics, the sophisticated language understanding capabilities of modern LLMs offer potential new avenues for operationalizing more complex theoretical frameworks.

Computational approaches to the automatic detection of intertextual relations are faced with two major non-obvious challenges: i) If any text can have relations with any other text, a huge number of text pairs needs to be processed. This in turn limits the (computational) complexity that can be invested on each pair. ii) Because language follows rules of grammar or efficiency, any two texts (in the same language) are almost guaranteed to contain similar token sequences. For instance, it will be hard to identify an English text that does not contain the sequence "to the", as

these are highly frequent tokens. The second challenge is thus to differentiate between 'spurious' and meaningful repetitions.<sup>1</sup>

We propose a two-stage approach that combines semantic similarity search with prompt-based analysis, aiming to leverage both the pattern-recognition capabilities of modern language models and the sophisticated theoretical frameworks developed by literary scholars. Our methodology treats semantic similarity as a practical heuristic for prioritizing computational resources rather than as a definitive indicator of intertextual relationships, with the LLM analysis serving as the interpretive layer that determines actual intertextual significance. As a concrete use case, we investigate intertextual relationships between Virginia Woolf's *Mrs. Dalloway* and Homer's *Odyssey*. While we acknowledge that the analysis is done on this specific case of intertextuality, we believe that the methodological insights can be generalized to other cases.

Our investigation thus focuses on two key methodological questions: First, can a two-stage approach combining semantic pre-filtering with prompt-based analysis provide a scalable framework for this kind of study? Second, how can domain-specific literary knowledge be effectively incorporated into LLM prompts to enable sophisticated intertextual analysis and how does this knowledge impact the performance of the prompts?

# 2 Background and Related Work

# 2.1 Foundations of Intertextuality

In her seminal work of the late 1960s, Julia Kristeva introduced the term "intertextuality" [15], which she conceptualized as "an intersection of textual surfaces rather than a point (a fixed meaning), as a dialogue among several writings" [16, p. 65]. She asserted that any text is "constructed as a mosaic of quotations; any text is the absorption and transformation of another" [16, p. 64]. This notion re-framed the understanding of literary works as dynamic networks of shared references, displacing the traditional focus on individual authorship and meaning. In this model, the very act of reading generates new interactions, since the reader's own textual experiences continually shape how intertextual connections are perceived.

Roland Barthes' observation that texts are "woven from cultural citations" [3, p. 190] amplifies Kristeva's dialogical perspective. Rather than existing as self-contained works, texts participate in a broader cultural fabric where meanings and references extend beyond their immediate boundaries. According to María Jesús Martínez Alfaro, this expanded view of textuality ultimately derives from Mikhail Bakhtin's concept of dialogism, underscoring that "a text cannot exist as a self-sufficient whole" [2, pp. 1–2]. However, while Kristeva's and Barthes' broad conceptualizations highlight the ubiquity of intertextual relationships, they offer limited guidance for systematic identification and analysis. As Alfaro points out, the proliferation of intertextual theories can risk "the progressive dissolution of the text as a coherent and self-contained unit of meaning" [2, p. 2], making it analytically difficult to distinguish where textual boundaries begin or end. This tension between theoretical richness and methodological feasibility set the stage for more structured approaches to intertextuality.

# 2.2 Toward Operational Definitions: Genette's Framework

Gérard Genette's typology of transtextual relationships sought to categorize textual interactions into identifiable types, offering a clearer lens for scholarly inquiry [6]. He identified five key modes of transtextuality: intertextuality, paratextuality, metatextuality, hypertextuality, and architextuality [6, pp. 1–7]. This systematization helped move beyond the notion that "everything is

text," introducing tractable categories that scholars – and later computational models – could more readily identify.

In this article, we focus on two subtypes: intertextuality and hypertextuality. Genette defined intertextuality as "a relationship of copresence between two texts or among several texts" and emphasized its manifestations in forms such as quotation, plagiarism, and allusion [6, pp. 1–2]. Hypertextuality, on the other hand, describes the relationship between a derived text (the hypertext) and its predecessor (the hypotext) and involves either direct transformation or imitation of the earlier work [6, pp. 5–6]. For example, *Ulysses* by James Joyce is a hypertext of Homer's *Odyssey*, transposing its themes and structures into a modernist framework.

Genette's framework highlights the interconnectedness of transtextual categories and their roles in analyzing textual transcendence. Hypertextuality, defined as the transformation or imitation of an earlier text (hypotext), can involve intertextual elements like allusions or quotations, which contribute to a derived work's relationship with its source [6, p. 5]

Recent years have also witnessed a number of scientific publications and activities with a clear computational agenda: Schubert highlights the importance of 'operationalizable' definitions that do not rely on interpretive hierarchies but can be systematically applied to large textual corpora [26, p. 4].<sup>2</sup> For different languages and use-cases, tools for interactive exploration have been published [12; 18], which focus on specific languages and/or authors, typically employing some kind of indexing database. In addition to the algorithmic work, the formal description of intertextual relations has received some attention [14; 20; 25].

## 2.3 LLMs for Intertextual Analysis

LLMs, such as GPT-4o [21], Phi-4 [1] or LLaMa 3 [8], offer promising avenues for detecting and analyzing intertextual phenomena. Advances in LLM prompting techniques, particularly *Chain-of-Thought* (CoT) prompting, enable models to articulate step-by-step reasoning processes, making their outputs more transparent and interpretable [28]. Retrieval-Augmented Generation (RAG), which pulls external context from sources like vector databases, has further mitigated issues of hallucination by grounding outputs in factual data [17].

Another key innovation is *In-Context Learning* (ICL), which allows models to adapt to new tasks based solely on natural language instructions and a few demonstrations provided at inference time, without requiring gradient updates or fine-tuning. ICL underpins the effectiveness of *Few-Shot Learning*, as demonstrated by Brown et al. (2020), enabling models to generalize and perform specialized tasks with minimal input examples. For computational literary studies (CLS), the synergy between ICL and few-shot learning is particularly advantageous: few-shot demonstrations provide models with the contextual knowledge needed to identify subtle intertextual patterns, while ICL ensures that the model dynamically applies these patterns across varied literary texts. For instance, these combined techniques can guide LLMs to identify subtle intertextual connections, such as thematic or stylistic parallels, with minimal additional input.

However, challenges persist, particularly in ensuring reproducibility, as even minor changes to the prompt or configuration can lead to divergent outputs [9; 27]. Bias in training data also presents a significant obstacle. As Bender et al. [4] caution, large corpora often reflect dominant cultural narratives, making LLMs more attuned to Western canonical references while potentially overlooking non-canonical or marginalized traditions. These biases necessitate careful prompt engineering and post-analysis to ensure equitable representation in computational intertextual studies.

## 2.4 Woolf, Homer, and the Case for LLM Analysis

Building on the opportunities outlined in the previous section, LLMs can be equipped with domain knowledge and examples to construct an intertextuality detection pipeline. This approach eliminates the need for annotated data and model fine-tuning, instead relying on *Few-Shot Learning* and *In-Context Learning* (ICL) to guide the LLM in identifying and interpreting intertextual relationships. Pichler and Reiter [23] highlight the potential of ICL for computational literary studies (CLS), noting its ability to integrate domain-specific knowledge dynamically through well-designed prompts, making it particularly suitable for nuanced tasks like intertextual analysis.

Virginia Woolf's *Mrs. Dalloway* offers a compelling case for applying such methodologies. Woolf's engagement with Homeric motifs reflects her characteristic approach to intertextuality, which operates across multiple levels – phonemic, thematic, and structural. Hoff [10] describes the novel as "pseudo-Homeric," highlighting Woolf's transformation of epic archetypes into a modernist framework, while Fernald [5] emphasizes her nuanced engagement with Homeric themes through subtle allusions and thematic echoes.

For instance, by incorporating expert knowledge – such as McCotter [19]'s analysis of Septimus Warren Smith's role as a critique of post-WWI mental health treatment – n LLM can provide a deeper, more contextually informed interpretation of Woolf's reframing of Homeric heroism. McCotter [19] emphasizes that Woolf used Septimus to highlight the inadequacy of contemporary medical practices and societal neglect of mental health, portraying his internal struggles as a modernist reinterpretation of classical heroism. This transformation moves away from the valor and physical endurance associated with Homeric figures, focusing instead on psychological trauma and alienation as central themes.

Equipped with carefully designed prompts that integrate such domain knowledge, an LLM could identify connections between Septimus and Homeric heroes more effectively. For example, it might recognize how Septimus's repetitive thoughts and feelings of guilt parallel Odysseus's introspective struggles, while simultaneously situating these patterns within the historical context of post-WWI trauma. Techniques like *Chain-of-Thought* prompting can further enhance this process by encouraging the model to articulate its reasoning step-by-step, aligning its outputs with established literary frameworks [28].

This domain-knowledge-driven approach exemplifies how LLMs could be harnessed to uncover intertextual relationships without requiring extensive pre-training or annotation efforts. In the case of *Mrs. Dalloway*, this enables scholars to explore Woolf's intertextual dialogue with Homer while accounting for her modernist and feminist transformations.

# 3 Detecting and Analysing Intertextual-References in Two Steps

The method we propose consists of two main stages: i) Vectorization of the texts in question, and their storage in a vector database to facilitate retrieval and ii) comparative analysis of similar chunks using a large language model. The two stages, together with necessary work steps are depicted in Figure 1. Due to the fact that all texts are (pre-)processed individually, the approach scales well even to larger corpora: The most 'expensive' method (prompting an LLM) is used only for promising candidate pairs.


The first step (vectorization) includes a number of preprocessing steps, and each of them a number of parameters to be set: Texts first need to be segmented, and there of course are different options on segmentation criteria, ranging from pragmatic, window-based to content-based criteria such as scenes. A number of different models can be employed to convert the segments into vectors, potentially even in different variants (cased vs. uncased). Finally, to retrieve similar chunks, different similarity metrics can be used (e.g., cosine, manhattan, ...).

The second step consists in the actual analysis of similar chunks, and the first parameter is

the way pairs are selected for further analysis. In addition the LLM context offers a number of parameters to be set: Next to the model itself, this is primarily the way the prompt is formulated, and in particular, how literary knowledge and theoretic foundations are included.

# 4 Experiments

This section outlines our experimental setup in order to implement and evaluate the two-step process described above. We have not done exhaustive testing of the different parameters described above, but focused on the prompt formulation, and in particular distinguish between a naive and an expert prompt.

#### 4.1 Corpus Selection and Preparation

The corpus for this study comprises Virginia Woolf's *Mrs. Dalloway* (1925) [29] and Homer's *The Odyssey*, using the Butcher and Lang translation [11]. This specific translation was chosen due to its documented presence in Virginia Woolf's personal library, which provides historical grounding for the analysis of intertextual relationships [13].

Both texts were sourced from Project Gutenberg, a freely available and widely used digital repository of public domain texts. This ensures consistency in the textual bases and facilitates future replication of the study.

Finally, the corpus preparation phase involved minor preprocessing to standardize formatting (e.g., removal of page numbers and erratic line breaks) while preserving the integrity of the original texts. This step was essential to ensure clean input for subsequent text segmentation and computational analysis.

#### 4.2 Text Processing and Segmentation

Our implementation employs a sentence-aware chunking strategy that balances computational requirements with literary coherence. Each segment contains ten sentences, roughly corresponding

to a 512-token window. This approach preserves semantic integrity by maintaining complete sentences and avoiding mid-sentence truncation that could otherwise disrupt literary analysis, while also retaining paragraph-level contextual relationships.

Other ways of segmentation are in principle also possible, yet lead to different problems: A segmentation by paragraph leads to a high variance in segment length and may occasionally also be too long for LLM analysis. At the same time, there is no unique and clear meaning assigned to paragraph boundaries as well.

## 4.3 Semantic Similarity Retrieval

Each chunk from the two corpora is then projected into a shared vector space using pre-trained embeddings, thereby enabling systematic comparison across texts [17].

We employ OpenAI's transformer-based embedding model text-embedding-3-small) to generate 1536-dimensional vector representations for each chunk. These embeddings are stored in a vector database, facilitating efficient similarity-based lookups.

For each query chunk q from  $Mrs.\ Dalloway$  with normalized embedding vector  $\vec{q}$ , we compute its similarity to all chunks o from  $The\ Odyssey$  with normalized embedding vectors  $\vec{o}$  using cosine similarity:

$$sim(q, o) = \frac{\vec{q} \cdot \vec{o}}{\|\vec{q}\| \cdot \|\vec{o}\|}, \tag{1}$$

where the equality holds due to L2 normalization ( $\|\vec{q}\| = \|\vec{o}\| = 1$ ). For each selected Mrs. Dalloway chunk, the system identifies both the most similar Odyssey passage ( $\arg\max_o \sin(q,o)$ ) and – for evaluative purposes – the most dissimilar passage ( $\arg\min_o \sin(q,o)$ ).

This bidirectional retrieval approach serves as a methodological control: by examining the LLM's analysis of both semantically similar and dissimilar passages, we can evaluate whether semantic similarity correlates with the detection of intertextual relationships. This design enables us to test the hypothesis that semantically similar passages are more likely to be classified as intertextual references, thereby providing a quantifiable baseline for assessing the LLM's analytical capabilities.

#### 4.4 Comparative Analysis through Prompting

Building on the semantic similarity retrieval process described in Section 4.3, we employ a *comparative prompting* approach to evaluate how differing levels of domain-specific knowledge affect the detection and analysis of potential intertextual and hypertextual connections. Inspired by prior work on prompt engineering and expert-in-the-loop strategies [27; 28], this methodology systematically contrasts a *Naive Prompt* – which encodes only fundamental transtextual concepts – with an *Expert Prompt* that integrates specific knowledge of Woolf's nuanced engagement with classical texts. For our experiment, we employed OpenAI's GPT-40 model (version gpt-4o-2024-08-06), a large language model with significantly enhanced reasoning capabilities compared to its predecessors [21], using a temperature setting of 0.5.

**Rationale.** As discussed in Section 2.3, LLMs can exhibit variability in outputs depending on prompt design and the extent of domain-specific information provided. By comparing analyses generated under two distinct prompting conditions (Naive vs. Expert), we aim to:

1. Evaluate how well an LLM can detect subtle intertextual cues *without* specialized background knowledge.

2. Assess whether supplying explicit scholarly perspectives on Woolf's intertextual practices (e.g., her feminist reframing of classics) improves the quality and depth of the model's literary analysis.

In both cases, it has to be assumed that a reasonably large LLM has been trained on both the primary texts (even on the specific editions, as they are included in Project Gutenberg). It is also likely that the model has 'seen' secondary literature about the two texts – interpretations and literary scholarly discussions –, including about their intertextual relationship. This likely has influence on the generalizability of our findings, but as both prompt types are executed on the same model, we consider the comparison of the prompt types to be generalizable.

**Naive Prompt.** The *Naive Prompt* (see Appendix A) provides the LLM with general definitions of intertextuality and hypertextuality grounded in Genette's terminology [7]. It instructs the model to identify possible references or transformations between *Mrs. Dalloway* and *The Odyssey*, highlighting key indicators such as direct quotations, allusions, and adaptations. However, the prompt does not include specialized knowledge of Virginia Woolf's modernist style or her specific mode of subtly embedding classical motifs [10].

**Expert Prompt.** In contrast, the *Expert Prompt* (see Appendix B) augments the same baseline instructions with targeted information about Woolf's literary methodology. Drawing on scholarship that situates Woolf's work within classical traditions [5; 10], this extended prompt explicitly instructs the LLM to look for:

- *Subtle allusions* at phonemic, thematic, or narrative levels.
- *Feminist transformations* of patriarchal narratives (e.g., downplaying elements of warfare or revenge).
- "Secret founts of pleasure" that Woolf sometimes includes without overtly signaling their Homeric roots. Molly Hoff [10] uses the term "secret founts of pleasure" to describe Virginia Woolf's subtle and intrinsic use of intertextual references in *Mrs. Dalloway*. These references are not intended for overt recognition by the reader but instead enrich the narrative as hidden gifts to the text itself. Unlike her contemporaries, such as T.S. Eliot or James Joyce, who often foreground their intertextuality, Woolf integrates allusions seamlessly at thematic, structural, and phonemic levels. Hoff illustrates this through examples such as Homeric allusions that quietly shape the novel's characters and themes.

By providing domain-specific context, we capture the multi-level engagement that scholars like Hoff and Fernald attribute to Woolf, thereby eliciting more focused and informed LLM outputs. **Example Analyses and Few-Shot Learning.** The example analyses differ between prompts in accordance with their knowledge scope. The Naive Prompt employs four generic literary examples spanning different periods and styles to demonstrate the application of Genette's framework across varied contexts. The Expert Prompt includes three examples of documented Woolfian intertextual relationships (see e.g., [5; 10]) alongside one non-Woolfian case. This approach operationalizes domain expertise by providing the model with canonical examples of Woolf's characteristic intertextual patterns as identified by literary scholars. While this creates different baseline knowledge between prompts, it directly tests our research question: whether grounding an LLM in documented scholarly examples enhances its capacity to detect similar patterns in unanalyzed passages.

To guide the LLM's behavior under both Naive and Expert prompts, we provide a set of *example analyses* within each prompt (few-shot learning). Following best practices for in-context learning [22; 28], these examples illustrate how to identify explicit and implicit references, as well as cases with no meaningful relationship. Including both "positive" and "negative" cases helps ensure the model can distinguish genuine intertextual resonances from incidental overlaps.

# 4.5 Structured Output Generation

To ensure consistent output generation, we adopt a *structured output* protocol that constrains the LLM to produce responses in a predefined format (Appendix C). Each analysis begins with initial observations and proceeds step-by-step through interpretive reasoning, mirroring academic methodologies and clarifying how textual evidence leads to final conclusions. This "thinking-steps-first" ordering aligns with recent chain-of-thought research [28]. It also reduces post-processing overhead, since each field (e.g., "Connections," "Evaluation") is generated in a uniform manner, facilitating direct scrutiny of interpretive claims.

#### 4.6 Evaluation Framework

To assess the quality of intertextual analyses produced by both prompting approaches, we implemented a blind evaluation methodology where the analysis of 20 randomly selected chunks from *Mrs. Dalloway* was evaluated on three dimensions using a standardized 5-point-Likert scale, with documented rationales for each score. For each chunk, the most similar and the most dissimilar *Odyssey* chunk was selected, and both pairs then presented to both the naive and expert prompt, leading to 80 evaluation pairs in total.

Assessment Dimensions. The evaluation framework examines i) evidence quality, ii) theoretical alignment, and iii) internal consistency. Scores for evidence quality range from 1 (no specific textual evidence) to 5 (comprehensive evidence with detailed analysis), measuring how effectively each analysis supports its claims with textual references. Scores on theoretical alignment evaluate understanding and application of Genette's transtextual framework and Woolf's modernist techniques, where 1 indicates surface-level comparison without theoretical grounding and 5 represents sophisticated analysis of how Woolf transforms Homeric themes through modernist and feminist perspectives. Scores on internal consistency assess logical coherence, ranging from contradictory claims (1) to thoroughly coherent analysis with strong supporting evidence (5).

**Process and Controls.** The evaluation process incorporated several methodological controls to ensure reliability. The order of the items was randomized, and the same annotation was done by two people. Prompt-type identifiers were removed to enable blind assessment.

### 5 Results

Our analysis revealed several key patterns in how 'our' LLM detects and interprets intertextual relationships between *Mrs. Dalloway* and *The Odyssey*, with notable differences between expertinformed and naive approaches. Before discussing these findings, we will look at the achieved inter-annotator agreement of the annotations.

## **5.1** Annotation Analysis

To ensure the reliability of our evaluation, two annotators evaluated the LLM's analyses independently of each other. A detailed breakdown of the inter-annotator agreement for each of the three quality metrics is presented in Table 1.

Overall, the agreement was robust, indicating a consistent application of the scoring criteria. Across all categories, the mean absolute difference between annotators was low, and the number of items with perfect agreement was high. For every single rating, the annotators' scores were never more than one Likert-point apart, achieving 100% agreement within a one-point margin.

Given the ordinal nature of our rating scales, we report both Pearson's r (measuring linear association) and Spearman's  $\rho$  (measuring rank-order correlation). The convergence between these two metrics across all categories demonstrates that the inter-rater agreement is robust regardless of the



specific correlation approach. Both measures show strong positive correlations, with Spearman's  $\rho$  ranging from 0.486 to 0.696.

The fact that Fleiss'  $\kappa$  scores are relatively low can easily be explained by the fact that Fleiss'  $\kappa$  takes the actual number of choices for a specific category into account. If many of the annotators' choices are concentrated on one or two labels, the expected agreement gets high, which in turn lowers overall  $\kappa$ .

A more granular analysis of the score distribution, broken down by annotator and category, further illuminates the evaluation tendencies (Figure 2). The aggregated results show that both annotators had remarkably similar scoring patterns, with almost identical proportions of positive, neutral, and negative ratings. This suggests that no single evaluator had a significant leniency bias.

The breakdown reveals different evaluation patterns across the categories. Both annotators scored 'Evidence Quality' conservatively, with the majority of scores being neutral. Conversely, they scored 'Theoretical Alignment' more positively. More strikingly, the scores for 'Internal Consistency' are overwhelmingly positive for both annotators, with 97.5 % and 87.5 % of scores being above 3, respectively, and no scores below 3.

This detailed distribution corroborates the explanation for the low Fleiss' Kappa value ( $\kappa = 0.331$ ) in the 'Internal Consistency' category given above. The concentration of scores in a narrow,

positive range (4s and 5s) demonstrates high practical agreement but results in a low Kappa value.

#### **5.2 Reference Detection Patterns**

The expert-informed prompt demonstrated a higher sensitivity in detecting intertextual references compared to the naive prompt, identifying references in 30% of analyzed passage pairs (n=12) versus 5% (n=2) for the naive prompt. This quantitative difference indicates that domain knowledge about Woolf's engagement with classical texts influences the LLM's capacity to classify text pairs as transtextual connections.

The effectiveness of our comparative analysis approach was validated by examining reference detection rates in similar versus dissimilar text pairs. For each of the 20 *Mrs. Dalloway* passages in our test set, we compared the analysis of its most similar and most dissimilar *Odyssey* counterparts. As shown in Table 2, the expert prompt identified references in 55 % of similar pairs versus 5 % of dissimilar pairs. The naive prompt showed a more stark contrast, finding references in 10 % of similar pairs but none in dissimilar pairs. This pattern suggests that semantic similarity serves as a meaningful indicator of potential intertextual relationships, particularly when combined with expert knowledge.

# 5.3 Analysis Quality Metrics

The quality of intertextual analyses was evaluated by two independent annotators across three dimensions: evidence quality, theoretical alignment, and internal consistency. A detailed breakdown of the scores for the naive and expert prompts, including individual annotator scores and the combined average, is presented in Table 3.

As shown in Table 3, this pattern of improvement with the expert prompt was consistent across both annotators. While both prompts generated analyses with good internal consistency and evidence quality, the expert prompt achieved a substantial advantage in theoretical alignment (+16.23%). This indicates that its analyses were more firmly grounded in literary theory and demonstrated a better understanding of Woolf's intertextual practices, a conclusion supported by both evaluators.

## 5.4 Theoretical Engagement and Bias

A notable finding emerged regarding the expert prompt's tendency toward over-interpretation. Analysis revealed that 90% of expert prompt analyses (n=36) mentioned classical transformations. This suggests a potential confirmation bias in the expert-informed system, where theoretical knowledge may lead to over-eager application of transformation frameworks.

# 5.5 Inter-Prompt Agreement

Analysis of inter-prompt agreement revealed high consensus on non-references but divergence in reference detection. As shown in Table 4, both prompts agreed on the absence of references in 70% of cases (n=28) and their presence in 5% of cases (n=2). The expert prompt uniquely identified references in 25% of cases (n=10), while the naive prompt never identified references that the expert prompt missed. This pattern suggests that expert knowledge enables the detection of subtle intertextual relationships that might be overlooked by a more general approach.

### 6 Discussion

This paper investigated two key methodological questions: (1) how to effectively operationalize domain-specific literary knowledge in LLM prompts for intertextual analysis, and (2) whether a two-stage approach combining semantic similarity pre-filtering with prompt-based analysis could provide a scalable framework for computational intertextual studies. Our findings offer insights into both the possibilities and limitations of using LLMs for sophisticated literary analysis tasks – but we should keep in mind that our analysis is based on a rather small test set from a specific pair of books. More general empirical investigations remain a desideratum.

## 6.1 Operationalizing Literary Knowledge

The integration of domain-specific knowledge through expert prompting revealed both promising capabilities and significant methodological challenges. While the expert prompt achieved higher theoretical alignment scores ( $\pm 16.23\%$ ) and demonstrated increased sensitivity in reference detection (30% vs 5%), the results highlight crucial considerations for operationalizing literary expertise in computational frameworks.

The disparity between naive and expert prompt performance suggests that LLMs can effectively leverage domain knowledge when properly contextualized. However, the expert prompt's tendency toward over-interpretation – evidenced by the 90 % rate of classical transformation claims and observed in manual inspection – reveals a fundamental challenge in operationalizing nuanced literary concepts. This pattern suggests that transforming qualitative literary expertise into computational parameters requires more sophisticated constraints than simple prompt augmentation.

## 6.2 Evaluating the Two-Stage Methodology

Our two-stage approach – combining semantic similarity pre-filtering with prompt-based analysis – demonstrated promising results for systematizing intertextual detection. The clear differentiation in reference detection rates between similar and dissimilar passages (55 % vs 5 % for expert prompt) validates the utility of semantic similarity as an initial filter. However, the fact that meaningful references were still identified in dissimilar passages (5 % by expert prompt) indicates that semantic similarity alone cannot capture the full spectrum of intertextual relationships.

The high inter-prompt agreement on non-references (70%) suggests that this approach can reliably identify passages without meaningful connections, while the expert prompt's unique identification of additional references (25%) indicates the value of domain knowledge in detecting subtle intertextual relationships. This hierarchical pattern points to the potential for developing more sophisticated multi-stage analysis pipelines.

# 6.3 Implications

These findings have several implications for computational literary studies:

- 1. **Knowledge Integration**: The successful transfer of literary expertise to LLM analysis requires more nuanced approaches than simple prompt augmentation. Future work should explore structured frameworks for constraining and validating domain knowledge application.
- 2. **Scalability Considerations**: The effectiveness of semantic pre-filtering suggests potential for scaling intertextual analysis to larger corpora, though careful attention must be paid to maintaining analytical rigor at scale.
- 3. **Validation Protocols**: The observed tendency toward over-interpretation highlights the need for robust validation frameworks specifically designed for computational literary analysis.

# 6.4 Limitations and Future Directions

Two fundamental validation questions remain for future work. First, we have not validated whether semantic similarity reliably indicates intertextual potential through comparison with manually annotated gold-standard data. While this would be clearly desirable, developing a gold standard on intertextual references comes with substantial challenges: Without any kind of pre-filtering, which in turn would need to make certain assumptions, the rate of negative cases (i.e., pairs without any intertextual relation) can be expected to be very high. This is not only frustrating to annotators (and may quickly lead to tiredness and inattention), it would also mean that the gold standard is very small or highly biased towards the negative class.

Second, we have not evaluated the precision of detected references. While they could be compared with established Woolf scholarship, this would only be insightful as a confirmation step, but not as refutation – after all, such a reference might not have been detected (or described) yet in the established body of literature. Evaluating the references from scratch would require significant literary expertise. Still, these validations would strengthen confidence in both the filtering mechanism and analytical accuracy.

Several methodological limitations warrant consideration. Most fundamentally, while our comparative approach of analyzing both similar and dissimilar passages provides evidence that semantic similarity correlates with reference detection rates, we have not validated the foundational assumption that high semantic similarity reliably indicates intertextual potential. Our methodology treats semantic similarity as a practical heuristic for prioritizing computational resources, with the LLM analysis serving as the interpretive layer that determines actual intertextual significance. However, future work should establish this baseline through manual annotation of a gold-standard corpus, comparing semantic similarity scores against expert-identified intertextual relationships to

quantify the precision and recall of similarity-based filtering. Additionally, the binary classification of similarity relationships (most similar vs. most dissimilar) may oversimplify the complex nature of intertextual connections. Our evaluation framework, while systematic, could benefit from more granular assessment criteria for different types of intertextual relationships.

#### 7 Conclusions

In this exploratory seminar paper, we investigated the potential of Large Language Models for computational analysis of intertextual relationships, focusing specifically on Virginia Woolf's *Mrs. Dalloway* and Homer's *Odyssey*. We developed and evaluated a two-stage methodology combining semantic similarity pre-filtering with prompt-based analysis, comparing the performance of expert-informed versus naive prompting strategies. Through systematic evaluation across multiple dimensions – including reference detection patterns, analysis quality metrics, and inter-prompt agreement – we demonstrated both the capabilities and constraints of LLM-based approaches to literary analysis. Our experimental results revealed significant differences between expert-informed and naive approaches, with the expert prompt achieving higher theoretical alignment (+16.23 %) and increased sensitivity in reference detection (30 % versus 5 %).

Our findings demonstrate both the potential and limitations of operationalizing literary analysis through LLMs. While the two-stage methodology shows promise for systematic intertextual detection, the challenges in effectively constraining domain knowledge application highlight the need for more sophisticated approaches to computational literary analysis. These results contribute to ongoing discussions about the integration of computational methods with traditional literary scholarship and suggest productive directions for developing more robust methodological frameworks.

## D.1.4 Comparative Analysis

This example demonstrates a fundamental difference between naive and expert prompting: the naive prompt did not mark the text pair as an intertextual relationship (*is\_reference: false*), while the expert prompt identified it as a thematic transformation (*is\_reference: true*).

### **Detection vs. Non-Detection**

The fundamental difference is binary: the naive prompt concluded there was "no meaningful intertextual relationship," while the expert prompt identified a hypertextual transformation. Both analyses recognized the shared craftsmanship motif, but interpreted its significance differently.

### **Interpretive Framework Differences**

The expert prompt's identification of this connection as a reference relied on recognizing:

- The thematic parallel between Penelope's weaving and Lucrezia's hat-making
- The transformation from "strategic deception" to "emotional refuge and artistic expression"
- The feminist reinterpretation of women's craft work
- · The shift from cunning to agency and creativity

The naive prompt, working without this interpretive framework, saw the same craftsmanship motif but concluded it was "common in literature" and therefore likely coincidental rather than intentional.

### **Score Patterns**

The naive analysis received higher evidence quality scores (4 vs. 3) despite missing the reference entirely, while the expert prompt achieved higher theoretical alignment scores (5/4 vs. 3/3). This pattern suggests:

- 1. The naive prompt's conclusion was internally coherent and well-evidenced *within its own framework*
- 2. The expert prompt's theoretical sophistication came from its interpretive lens rather than from identifying different textual evidence
- 3. Evidence quality assessment may be somewhat independent of whether the correct conclusion is reached
- 4. Both analyses had high internal consistency (4 vs. 5), indicating logical coherence regardless of interpretive framework

**Significance:** The connection highlights the universal themes of death and longing for connection, enriching the existential reflections in Mrs. Dalloway and linking them to the classical narrative of The Odyssey.

**Interpretation:** The intertextual connection suggests that Woolf may be engaging with classical themes to explore modern existential concerns, using the motif of death as a means of communication and isolation.

**Uncertainties:** The connection is based on thematic parallels rather than direct references, which may lead to different interpretations of Woolf's intentions.

**Conclusion:** There is a meaningful thematic relationship between the texts, suggesting that Woolf may be alluding to The Odyssey in her exploration of death and connection.

# D.2.3 Expert Prompt Analysis

**Initial Observations** The passages from Mrs. Dalloway and The Odyssey both explore themes of death, longing, and the inability to fully connect with others. In Mrs. Dalloway, Clarissa reflects on death as a form of communication and defiance, while in The Odyssey, Odysseus encounters the spirit of his mother and experiences the sorrow of being unable to physically embrace her. Both texts convey a sense of isolation and the ephemeral nature of life and relationships.

### **Connection 1: Death as Communication and Isolation**

- Type: Intertextual

## **Connection 2: Societal Pressures and Longing**

• **Type:** Hypertextual

- **Odyssey Evidence:** Odysseus's longing for his mother's embrace and the sorrow of separation: "sharp grief arose ever at my heart."
- Mrs. Dalloway Evidence: Clarissa's reflection on the terror and incapacity of life, and the societal pressures imposed by figures like Sir William Bradshaw: "Life is made intolerable; they make life intolerable, men like that."
- **Explanation:** Woolf transforms the classical theme of longing and separation into a modern context, focusing on the internal struggles and societal pressures faced by women. This hypertextual transformation critiques patriarchal structures and highlights the psychological impact of isolation and longing.

### **Evaluation**

**Intentionality:** The thematic parallels and transformations suggest that Woolf may have intentionally engaged with classical themes from The Odyssey, reinterpreting them through a modern and feminist lens.

**Significance:** The connections highlight Woolf's ability to weave classical themes into her narrative, enriching the text with layers of meaning and critique of societal norms.

**Interpretation:** Woolf's text can be seen as a modern reflection on the timeless themes of death, longing, and isolation, with a particular focus on the female experience and critique of patriarchal structures.

**Uncertainties:** While the thematic parallels are clear, it is uncertain whether Woolf intended a direct reference to The Odyssey or if the connections are more broadly inspired by classical literature.

**Conclusion:** The analysis suggests a meaningful relationship between the texts, with Woolf's Mrs. Dalloway engaging with and transforming themes from The Odyssey.

### D.2.4 Comparative Analysis

Unlike Example 1, both prompts identified this as an intertextual reference (*is\_reference: true*), allowing comparison of analytical sophistication when the fundamental detection task succeeds.

# **Detection Convergence**

Both the naive and expert prompts recognized the death/longing parallel as an intentional intertextual relationship. This convergence suggests that some thematic parallels are sufficiently clear that even naive prompting can detect them as meaningful references.

### **Depth of Analysis**

The expert prompt identified 2 connections while the naive prompt identified 1 connection, demonstrating how domain knowledge can enable recognition of additional layers of intertextual engagement. The expert prompt's second connection – linking Odysseus's grief to Clarissa's critique of Sir William Bradshaw and patriarchal structures – represents a more sophisticated reading that the naive prompt did not attempt.

# Confidence and Theoretical Alignment

The expert prompt demonstrated higher confidence (High vs. Medium) in its primary connection and achieved higher theoretical alignment scores (5/4 vs. 4/4 from annotators), reflecting its integration of interpretive frameworks about feminist reinterpretation and modern transformation of classical themes. However, the expert prompt received lower evidence quality scores (3 vs. 4), suggesting that the additional theoretical sophistication may have come at the cost of more speculative claims about textual evidence.

## **Score Patterns**

The score patterns reveal an interesting trade-off:

- Naive: Higher evidence quality (4), moderate theoretical alignment (4), high internal consistency (5/4)
- Expert: Lower evidence quality (3), higher theoretical alignment (5/4), high internal consistency (4)

This suggests that the expert prompt's second connection (the hypertextual transformation involving Sir William Bradshaw) may have been viewed by annotators as more interpretively ambitious but less directly supported by textual evidence.

# **Implications**

This example demonstrates that when both approaches successfully detect an intertextual relationship, domain knowledge primarily enhances analytical depth rather than enabling detection. The expert prompt's ability to identify a second, more complex connection – transforming classical longing into a critique of patriarchal structures – shows how interpretive frameworks enable recognition of multiple layers of intertextual engagement that naive prompting may miss.

# D.3 Example 3: Emotional Surrender in Dissimilar Passages

This example demonstrates a case where expert knowledge enabled the identification of an intertextual relationship in a text pair with *low semantic similarity* (most dissimilar pair).

### D.3.1 Text Pair

# Mrs. Dalloway:

## D.3.2 Naive Prompt Analysis

**Initial Observations** The passages from Mrs. Dalloway and The Odyssey appear to have different contexts and themes. The Mrs. Dalloway passage focuses on emotional despair and a sense of hopelessness, while The Odyssey passage involves a scene of feasting and a contest of archery. The semantic similarity score is moderate, suggesting some thematic or emotional parallels but not direct textual connections.

### **Connection Identified**

**Connection: No Meaningful Connection** 

- Type: None
- **Odyssey Evidence:** The Odyssey passage involves a feast and a contest of archery, with themes of divine intervention and testing of strength.
- Mrs. Dalloway Evidence: The Mrs. Dalloway passage focuses on emotional despair, lone-liness, and a sense of surrender.
- **Explanation:** The thematic elements of emotional despair and surrender in Mrs. Dalloway do not directly relate to the competitive and anticipatory themes in The Odyssey. The contexts and purposes of the passages are distinct, with no clear intertextual relationship.

#### **Evaluation**

**Intentionality:** The connections between the passages appear coincidental rather than intentional. The themes of emotional despair and competition are common in literature but do not suggest a direct reference.

**Significance:** The lack of direct intertextual connections means there is no significant literary relationship between the passages.

**Interpretation:** The passages reflect different thematic concerns and emotional tones, with no meaningful intertextual dialogue.

**Uncertainties:** There is a possibility of thematic parallels being interpreted differently, but the lack of direct textual evidence supports the conclusion of no intentional reference.

**Conclusion:** There is no meaningful relationship between the texts based on the analysis.

### D.3.3 Expert Prompt Analysis

**Initial Observations** The passages from Mrs. Dalloway and The Odyssey both involve themes of emotional struggle and surrender, though they manifest in different contexts. The Mrs. Dalloway passage focuses on a character's internal emotional descent and surrender, while The Odyssey passage involves a strategic pause in a contest, with Odysseus preparing to reveal his strength. The similarity score suggests some thematic overlap, but the contexts and narrative functions differ significantly.

### **Connection Identified**

Connection: Surrender and Descent

• **Type:** Hypertextual (transformation)

- **Odyssey Evidence:** In The Odyssey, Antinous suggests pausing the contest and leaving the outcome to the gods, reflecting a strategic surrender to fate.
- **Mrs. Dalloway Evidence:** In Mrs. Dalloway, the character experiences an emotional surrender, feeling nothing as his wife cries, and ultimately gives in, needing others to help him.
- **Explanation:** Woolf transforms the theme of surrender from a strategic pause in a contest (The Odyssey) to an emotional surrender in a personal crisis (Mrs. Dalloway). This transformation shifts the focus from external, strategic struggles to internal, emotional struggles, reflecting Woolf's modernist focus on psychological depth and complexity.

• Confidence: Medium

#### **Evaluation**

**Intentionality:** The thematic transformation appears intentional, as Woolf often reinterprets classical themes to explore modern psychological and emotional landscapes.

**Significance:** The transformation highlights Woolf's focus on internal emotional struggles, contrasting with the external, strategic struggles in The Odyssey, and contributes to her broader exploration of modern consciousness.

**Interpretation:** Woolf's passage can be seen as a modern reinterpretation of classical themes, focusing on the internal emotional struggles of modern life rather than external contests.

**Uncertainties:** The connection relies on thematic transformation rather than direct textual evidence, which may lead to different interpretations of Woolf's intentions.

**Conclusion:** A meaningful relationship exists between the texts through thematic transformation, reflecting Woolf's modernist reinterpretation of classical themes.

**Is Reference:** True **Annotator Scores**

### D.3.4 Comparative Analysis

## **Low Similarity, Divergent Detection**

With a similarity score of only 0.607 (most dissimilar pair), this represents a case where the two prompts reached opposite conclusions again (as in Example 1): the naive prompt concluded there was no meaningful intertextual relationship (*is\_reference: false*), while the expert prompt identified a hypertextual transformation (*is\_reference: true*).

## **Contrasting Interpretations**

Both analyses recognized similar thematic elements (surrender, emotional states), but interpreted their significance differently:

- Naive: Identified themes of emotional despair versus competition as "distinct, with no clear intertextual relationship," concluding the connections "appear coincidental rather than intentional"
- **Expert:** Recognized the same contrast but interpreted it as a transformation: "Woolf transforms the theme of surrender from a strategic pause in a contest (The Odyssey) to an emotional surrender in a personal crisis (Mrs. Dalloway)"

# **Confidence Levels**

Notably, the prompts showed contrasting confidence levels:

- Naive: High confidence in the conclusion of no relationship
- **Expert:** Medium confidence in identifying the transformation

This pattern suggests that the naive prompt was certain about dismissing the connection, while the expert prompt, despite identifying a relationship, maintained appropriate epistemic humility about working at an abstract level of transformation.

## **Theoretical Alignment Gap**

The scoring pattern reveals a significant theoretical alignment gap:

- Naive: Theoretical Alignment scores of 3 from both annotators
- Expert: Theoretical Alignment scores of 5 and 4

This 2-point gap (3 vs. 5) reflects the expert prompt's ability to frame the connection within theoretical frameworks about Woolf's modernist transformation techniques, even when working with low-similarity passages. Both analyses received identical evidence quality scores (3), suggesting they worked with similar textual evidence but interpreted its significance differently.

## **Methodological Implications**

This example raises important questions about the nature of intertextual analysis:

- 1. The expert prompt's identification of a "hypertextual transformation" at this level of abstraction demonstrates how domain knowledge could enable recognition of connections that operate beyond surface-level textual features
- 2. The naive prompt's high-confidence dismissal of the connection suggests that without interpretive frameworks, abstract thematic transformations may be indistinguishable from coincidental overlap
- 3. the LLM analysis layer can potentially identify connections that semantic similarity alone cannot capture

However, this example also highlights challenges: the expert prompt's medium confidence and the abstract nature of the connection ("strategic surrender" to "emotional surrender") suggest this represents a more speculative form of intertextual analysis compared to Examples 1 and 2.
